

Kayak Rental Agreement - Waiver and Release of Liability Assumption of Risk:

I understand and accept that renting this kayak and participating in kayaking exposes me to many hazards and entails unavoidable risk of death, personal injury (including but not limited to drowning or bodily injury) and loss of or damage to property. I also understand I should be in good physical health to participate in kayaking. I choose to participate in kayaking despite these risks and hereby assume all risk of injury or loss of life to myself and loss of or damage to property arising out of renting this kayak and participating in kayaking. I understand the inherent risk involved in using this equipment; accept full responsibility for any and all such damage or injury which may result.

Waiver and Release: In consideration of Bigfoot Kayak Rentals and Tours LLC, renting me this kayak, I specifically release and forever discharge and its officers, agents, and employees from any and all liability or claims for injury, illness, death or loss of or damage to property which I may suffer while renting this kayak and participating in kayaking. This discharge specifically includes, but is not limited to, liability or claims for injury, illness, death, or damage caused by the negligence of B-A-C or its officers, agents, or employees. It is my intent by the Waiver and Release Agreement to release B-A-C and hold it harmless from all liability for any such property loss or damage, personal injury, or loss of life, whether caused by the negligence of B-A-C or whether based upon breach of contract, breach of warranty, or any other legal theory. In signing this document, I fully recognize that if injury, illness, death, or damage occurs to me while I am engaged in renting this kayak or participating in kayaking, I will have no right to make a claim or file a lawsuit against B-A-C or its officers, agents, or employees, even if they or any of them negligently cause my injury, illness, death, or damage.
